## Information concerning processing of personal data ex art. 13 of the EU Regulation 2016/679

#### Data controller

In accordance to the EU Regulation 2016/679 (infra: Regolamento), we inform you that your personal data will be handled by MOTTURA S.p.A. as Data Controller (hereinafter "Titolare").

## Categories of data to be processed

The Ownership will handle your personal data (art. 4(1), collected under the scope of the contract and/or for the purpose of concluding the same with your company (hereinafter "il Cliente"), including, but it is not limited, name, surname, mobile phone number, email address and, overall, your contact details as representative of the client.

#### Purposes, legal basis and optional data handling

Your personal data will be handled for the following purposes:

- a) Performance of the contract and/or pre-contractual measures
  - Legal basis for the processing is the performance of a contract to which the data subject is party or in under to take steps at the request of the data subject prior to entering into a contract (art. 6(1)(b)) of the Regulation).
- b) Fulfillment of any legal obligations
  - Legal basis for the processing relates to compliance with a legal obligation to which the controller is subject (art. 6(1)(c) of the Regulation)
- c) Monitoring of reliability and solvency
  - Legal basis for the processing are the legitimate interests pursued by the controller aimed to the supervision of administrative and economic management (art. 6(1)(f) of the Regulation)
- d) Handling of disputes
  - Legal basis for the processing are the legitimate interests pursued by the controller aimed to the defence of legal and administrative claims (art. 6(1)(f) of the Regulation)

Provision of your personal data for the above mentioned purposes is not compulsory, but in its absence, it will not be possible to perform the contract.

Besides your personal data will be handled for the following purpose, without your specific consent:

e) sending of marketing and promotional communications by mail, concerning goods or services similar to those covered by the agreement, in accordance to the General Provisions of the Personal Data Protection Authority "Linee guida in materia di attività promozionale e contrasto allo spam" of 4 July 2013

Legal basis for the processing is the performance of a contract to which the data subject is party (art. 6(1)(b) of the Regulation.

The personal data granting for the purpose described in subparagraph e) is optional; there will be no consequences if you do not accept.

## Data recipients and transfer of personal data

Your personal data can be shared with:

• Physical persons authorized by the data controller after the signing of a nondisclosure agreement (e.g. employees and system administrators of MOTTURA S.p.A.);

Advisers and credit institutions for accounting purposes, companies of the group, contractors when the job, even in part, has been entrusted to external companies, some of them acting as controllers (for the full and updated list of data controllers, please contact <a href="mailto:privacy@mottura.com">privacy@mottura.com</a>);

• Persons, entities or authorities to whom it is mandatory to submit your personal data in accordance with provisions laid down by law.

The data controller does not transfer your personal data in countries that are not members of the European Union.

# Storage of personal data

Your personal data shall be stored only for as long as necessary for the performance obligations set out in the contract. In any case, it is without prejudice to the continued storage imposed in accordance with the relevant legal provisions, such as the one required by the art. 2946 of Civil Code.

# Data subjects' rights ex art. 15 and ff. of the Regulation

At any time you have the right to contact the Data Handling Owner for the access to your personal data, the rectification or deletion of the sames, the restriction of the processing of data or to obtain your data in a structured format, commonly and machine-readable, in the circumstances provided for in art. 20 of the Regulation.

Besides we inform you that, according to ex art. 21 of the Regulation, you have the right to object to the processing of your personal data, for legitimate reasons, initially or during subsequent communication relating to the processing.

In any case we inform you that according to art. 77 of the Regulation, you have always the right to object to processing of your personal data lodge a complaint with the competent control authority (Personal Data Protection Authority), if you consider that processing of your personal data is contrary to the existing legislation.
