Information concerning processing of the supplier's personal data as per ex art. 13 of the EU Regulation 2016/679

Data controller

In accordance to the EU Regulation 2016/679 (infra: Regolamento), we inform you that your personal data, collected for the purposes of managing the contract and performing legal obligations, will be handled by MOTTURA S.p.A. with its headquarter in S.Giusto Canavese (TO), Via XXV Luglio 1, as Data Controller (hereinafter "Titolare").

Categories of data to be processed

The Ownership will handle your personal data (art. 4(1), collected under the scope of the contract and/or for the purpose of concluding the same with your company (hereinafter "il Fornitore"), including, but it is not limited, name, surname, mobile phone number, email address and, overall, your contact details as representative of the supplier.

Purposes, legal basis and optional data handling

Your personal data will be handled for the following purposes, without the need of your specific consent:

a) Implementation of precontractual measures

Legal basis for the processing is the implementation of precontractual measures (art. 6(1)(b)) of the Regulation) (i.e. evaluation of new suppliers, public tendering);

b) Performance of the contract

Legal basis for the processing is the performance of a contract or the implementation of precontractual measures to entering into a contract (art. 6(1)(b)) of the Regulation);

c) Fulfillment of any legal obligations

Legal basis for the processing is the fulfillment of legal obligations to which the controller is subject (art. 6(1)(b)) of the Regulation) (i.e. obligations provided by D.Lgs. 81/08 concerning occupational health and safety with a request of the names of the staff (full name, freshman, date and place of birth, date of engagement) who will carry out interventions at our headquarters with a specific declaration meeting the requirements of technical - professional competence and their INPS and INAIL position as well as the National Collective Labour Agreement applied);

Provision of your personal data for the above mentioned purposes is not compulsory, but in their absence, it will not be possible to finalise the contract.

Data recipients

Your personal data can be shared with:

- Physical persons authorized by the data controller after the signing of a nondisclosure agreement (e.g. employees of the Administration and Personnel Department, system administrators);
- Advisers and credit institutions for accounting purposes, companies of the group acting as controllers (for the full and updated list of data controllers, please contact <u>privacy@mottura.com</u>);

- Persons, entities or authorities to whom it is mandatory to submit your personal data in accordance with provisions laid down by law.
- Persons, entities or authorities to whom it is mandatory to submit your personal data in accordance with provisions laid down by law.

Storage of personal data

Your personal data shall be stored only for as long as necessary for the performance obligations set out in the contract. In any case, it is without prejudice to the continued storage imposed in accordance with the relevant legal provisions, such as the one required by the art. 2946 of Civil Code.

Data subjects' rights ex art. 15 and ff. of the Regulation

At any time you have the right to contact the Data Handling Owner for the access to your personal data, the rectification or deletion of the sames, the restriction of the processing of data in the cases referred to in art. 18 of the Regulation or to obtain your data in a structured format, commonly and machine-readable, in the circumstances provided for in art. 20 of the Regulation.
